"JUNETEENTH" pays tribute to the official announcement of the abolition of slavery in Texas by Union General Gordon Granger (and 2,000 federal troops) in 1865--nearly 3 years after Abraham Lincoln had declared all slaves be freed. In 1872, Freeman's town residents Jack Yates, Elias Dibble, Richard Allen & Richard Brock purchased 10 acres at Dowling & Elgin and dedicated "Emancipation Park" as a place to celebrate Juneteenth. In 1973, C. Anderson Davis, founder of The National Emancipation Association initiated Houston's Juneteenth Parade north on Dowling to Emancipation Park. In 1979, State Representative Al Edwards sponsored the bill that made June 19th a Texas State holiday beginning in 1980.

It is expressly agreed and understood between the Exhibitor or Vendor and the 2013 Juneteenth Emancipation Celebration Collective (hereafter referred to as "Friends of Emancipation Park") that the Friends of Emancipation Park shall NOT be liable for loss or damage to goods or property of Exhibitors and Food Vendors or personal injury to the Exhibitor, said employees or customers and each Exhibitor and Food Vendor on signing the attached Vendor Agreement expressly releases 2013 Juneteenth Emancipation Celebration, the City of Houston, the 2013 Juneteenth Emancipation Celebration Collective, their entities, Exhibits Managers, sponsors, volunteers, and/or assignees from and agrees to hold them harmless from all claims including cancellation due to inclement weather or acts of God. Each Exhibitor & Food Vendor further warrants that he/she will obey all rules, regulations and laws of the event and the City of Houston. This is a family-oriented community event. Entertainment and vendors with obscene/explicit materials and offerings are asked not to apply. Friends of Emancipation Park reserves the right of refusal of application and/or expulsion from the event without refund.

REFUNDS: No refunds or credits will be issued once an application has been received and accepted.

BOOTH SPACE Though preferences are taken into consideration, Vendor will receive a space as per the decisions of the event and applicable Exhibits Managers. Vendor is responsible for the cleanup of their space at event's end. Failure to comply will warrant a \$50 charge.

ELECTRICAL REQUIREMENTS

Your electrical specification request will be taken into consideration, but will be allowed only at the discretion of the Exhibits Manager. Battery operated equipment is suggested. Because some vendors will require electricity and others will not, those businesses will have to be approved by the Exhibits Manager and may require an extra charge

EACH EXHIBITOR must be set up within the area of the space leased as approved by the Exhibits Manager and assigned by Friends of Emancipation Park officials. Authorized street vendors with mobile carts are the exception to this rule. Requests to relocate are at the discretion of the Exhibit Manager.

MERCHANDISE SECURITY

Sale of such unauthorized items will result in the vendor's immediate removal from the event without a refund and possible litigation.
